This Tariff contains the descriptions, regulations, and rates applicable to the furnishing of competitive local exchange and interexchange telecommunications services provided by Granite Telecommunications, LLC (“Company”) within the State of Georgia. Attached is a Frontier Communications of Georgia, LLC (Fairmount Study Area) tariff filing issued January 29, 2026 and dated to become effective March 1, 2026, subject to Georgia Public Service Commission approval. The purpose of this filing is to increase the Network Access Charge for Rotary. The Company currently plans to discontinue this service on or after June 1, 2025. The fund shall be administered by the commission pursuant to this Code section and under rules to be promulgated by the commission as. Instead of setting prices for telecommunications services, the Commission now manages and facilitates the transition to competitive markets, establishes and administers a Universal Access Fund (UAF) to assure reasonable access to services in high cost areas, monitors rates and service quality, and.
