



Legal regulations for installing photovoltaic panels on roofs



Overview

Yes, most solar panel installations require permits. Whether you're installing rooftop panels or a ground-mounted system, local building departments typically require permits to ensure safety, code compliance, and proper grid connection. Permitting and inspection are required before a solar array is allowed to produce electricity on the grid. While federal guidelines provide a baseline, local jurisdictions often implement additional requirements affecting everything from permit costs to HOA.
