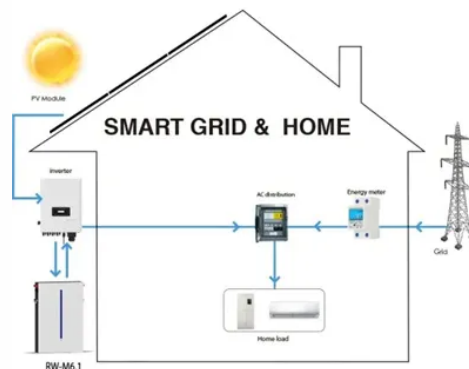




Mutual assistance new solar power generation and heating
