Overview

For all methods of transport the U.S. legal requirements are laid down in the Code of Federal Regulations (CFR 173.159) which state: 1. Batteries should be individually wrapped so that there is no chance of the terminals coming into contact with any external material or other battery terminals in the same package -. Non-spillable lead acid batteries (those that use Gel or Absorbent Glass Matt technology) require the same packaging as those filled with acid. Carriers will usually require these to be drained of acid and enclosed in an acid proof liner. Some may state that the battery is also covered with soda ash (which neutralizes acid). Check with your carrier for specific. Just because your lead acid battery won't do what you want it to do like start and engine does not mean that it is completely dead. Shorting out the terminals could still cause over-heating, an.

Import Duty. Import duty on batteries depends on the HS code and the origin of the product. Legal Regulation: According to the Law on Export and Import Duties 2016 and Decree No. 57/2020/ND-CP, import duty rates for batteries range from 5% to 25%. Example: Lead-acid batteries under HS Code 8507.10.00 may be subject to a 20% import duty rate.

Used lead acid batteries (ULABs) are a hazardous waste. The Hazardous Waste (Regulations of Exports and Imports) Act 1989 and Hazardous Waste (Regulation of Exports and Imports) (OECD Decision) Regulations 1996 regulate the export and import of ULABs. You need a permit to import or export whole or broken ULABs or their components.
