Lithuania has decided to tighten its cybersecurity laws, banning manufacturers from countries deemed national security threats, including China, from remotely accessing management systems of solar, wind, and storage facilities. The European Solar Manufacturing Council has backed the move. The Article 733: Security Requirements for the Control Systems of Electricity Devices law aims to strengthen security measures for. Lithuania's Ministries of Energy and the Environment have jointly approved an additional €37 million in funding to expand the country's capital expenditure (capex) support for energy storage projects. The country has been actively developing large-scale battery energy storage systems, with projects such as the 291 MW. The new legislation will address the risks associated with the remote controllability of PV inverters that we at European Solar Manufacturing Council (ESMC) have highlighted lately.
