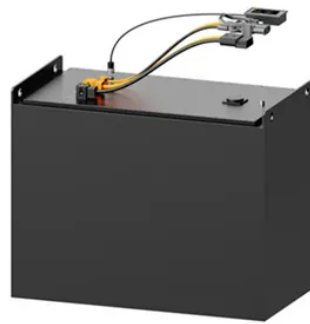

As part of the 2018 Energy Storage Order, the Commission established a statewide energy storage goal of 3,000 megawatts (MW) of qualified energy storage systems by 2030, with an interim objective of deploying 1,500 MW of energy storage by 2025. 1 The.
